All undergraduate students enrolled full time (taking 12 or more credit hours at Tulane) are REQUIRED to reside in the residence halls during their first and second year (freshman and sophomore years). Class year is based on total academic years in college, not credit hours earned. This policy does not apply to transfer students entering Tulane as a freshman (mid-year) or as a sophomore/second-year student (either in August or mid-year). To request an exemption to the residency requirement, students must provide verification of one of the following by June 1 (first-year students) or February 24 (second-year students):

- 1) Local residency with a parent or legal guardian (see explanation and details below)
- 2) 21 years of age by the first class day of the fall semester
- 3) Legally married by June 1 (first-year students) or February 24 (returning students)

For local freshmen and sophomores who prefer to live at home with a parent or legal guardian, the following items must be submitted by **June 1 (first-year students)** or **February 24 (second-year students)**. Letter of consent from the parent or guardian verifying your residency with them for the following academic year,

- 1) Verification of local address as primary residence of the parent or guardian. This can be verified by submitting one of the following:
 - a) Current utility bill with parent or guardian name included, along with a matching driver's license (copies one, please delete or "blackout" social security information).
 - b) Current lease or rental agreement along with matching driver's license or matching utility bills.

Note: Living in a parent or guardian's secondary or non-primary residence (such as a rental unit) does not constitute living with a parent or guardian in their primary residence.
